


Industry Intelligence & Commentary

26 Apr: Signa Prime Collection, the Austria-based property company, has reportedly sold the 210-key Hotel Bauer in Venice, Italy along with three other properties for an undisclosed sum to Schoeller Group, the Germany-based conglomerate, according to Reuters. According to the same source, the Hotel Bauer is currently under renovation and is due to reopen a 110-key Rosewood-branded luxury hotel in 2025.

25 Apr: Hyatt Hotels Corp, the US-listed hotel owner and operator, announced it has completed the integration of over 700 boutique luxury hotels onto the World of Hyatt platform. The properties, which are participating hotels and villas from Mr & Mrs Smith, the luxury hotel platform that Hyatt acquired in 2023, will be available for members to book online effective immediately, and will quality for earning and redeeming loyalty points.

25 Apr: Marriott International, the US-listed hospitality group, announced it has signed an agreement with NEOM, the Saudi Arabia-based real estate development group, to open its second The Ritz-Carlton Reserve in Trojena, a mountain destination in Saudi Arabia. According to the announcement, the resort is expected to feature 60 villas with a range of amenities including a spa, swimming pools, and multiple culinary venues.

24 Apr: Preferred Hotels & Resorts, the US-based hospitality recognition platform, announced the addition of 15 new member properties to its global portfolio of independent hotels and resorts. Each of the new properties participates in 1 Prefer Hotel Rewards, the brand's points-based loyalty program with 5 million travellers enrolled globally.

23 Apr: Minor Hotels, the Thailand-listed hospitality and retail group, announced that its subsidiary NH Hotel Group, the Spain-based hospitality group, will now operate as Minor Hotels Europe & America, effective immediately, following a vote by the NH Hotel Group shareholders. According to the announcement, Minor Hotels Europe & Americas is currently responsible for over 350 properties in 30 countries, and has plans to grow across all segments, with a focus on upper-upscale and luxury brands. It has a pipeline of 200 hotels expected to be added to its portfolio by 2026, 50 of which will be in Europe.
