Industry Intelligence & Commentary

7 May: KKR, the US-listed asset management group, and Marriott International, the US-listed hotel group, announced the launch of each company's foray into the midscale hospitality space in Japan, following KKR's completion of the acquisition of a 3,600-key, 14-hotel portfolio from Unizo Holdings, the Japan-based hotel chain. As part of the transaction, the 14-hotel portfolio, located across major tourist destinations across Japan, will be rebranded and repositioned under the Four Points Express by Sheraton flag and are expected to open during H2 2024.

6 May: Braemar Hotels & Resorts, the US-listed hospitality real estate investment trust, announced the sale of the 394-key Hilton Torrey Pines in La Jolla, CA for US\$165 million (approx. US\$418,800 per key) to an undisclosed purchaser. According to the press release, including anticipated capital expenditures of US\$40 million, the sale price reflects a 7.2% cap rate on net operating income for the trailing twelve months ended March 31, 2024.

2 May: Vail Resorts, the US-listed mountain resort group, announced it has completed the previously reported acquisition of Crans-Montana Mountain Resort in Switzerland from CPI Property Group, the Germany-listed real estate investment group. According to the press release, the acquisition included an 84% stake in Remontées Mécaniques Crans Montana Aminona SA, which controls and operates all the resort's lifts and supporting mountain operations, a 100% stake in SportLife AG (up from the 80% previously announced), which operates one of the ski schools located at the resort, and 11 restaurants located at and around the mountain resort. The transaction value was US\$130.6 million and Vail is planning to invest an additional c.US\$33 million over the next five years to maximize food and beverage efficiencies and improve and expand snowmaking capabilities at Crans Montana.

1 May: Host Hotels & Resorts, the US-listed hospitality REIT, announced the acquisition of the fee simple interest in a two-hotel complex comprising the 215-key 1 Hotel Nashville and the adjacent 506-key Embassy Suites by Hilton in Nashville, TN for c.US\$530 million (approx. US\$735,000 per key) from Starwood Capital Group, the US-based real estate investment group, Cresent Real Estate, the US-based real estate development and investment group, and High Street Real Estate Partners, the US-based real estate investment firm. According to the press release, the acquisition price represents a 12.6x EBITDA multiple or approx. 7.4% cap rate on the 2024E results of the combined properties.
